



## 1. Regulatory Standing of HUMB

HUMB is a fully regulated VASP, duly licensed under Lithuanian law by the Bank of Lithuania. As you are aware, Lithuania is a member of the European Union, and its regulatory approvals are issued in line with the EU's harmonized approach to financial services. This means that our license is not confined to a single jurisdiction but is part of a broader framework consistent with the **Markets in Crypto-Assets Regulation (MiCA)** and aligned with **Financial Action Task Force (FATF)** international standards (see **Appendix A**).

## 2. International Corporate Expansion Based on VASP Approval

HUMB has leveraged its Lithuanian VASP license as the regulatory foundation to expand responsibly and establish duly incorporated entities in multiple jurisdictions, each capable of handling digital assets in compliance with local requirements. These include:

- **Indonesia** (Company No. 1405250027936)
- **Africa** (Company No. 17503295483)
- **Canada** (Company No. BC1531035)
- **Saint Vincent and the Grenadines** (Company No. 3646LLC2024)
- **India** (Company No. U72900PN2023PTC217964)

Copies of the respective company incorporation certificates are enclosed with this submission. This demonstrates that HUMB's VASP approval is not only valid within the EU but has also served as a sufficient regulatory foundation to establish compliant, regulated businesses globally.

## 3. Prior Approval as Precedent

We would also like to highlight that Apple has previously approved the HUMB iOS application on the basis of this same VASP license. The updated version of our app does not represent any change in our licensing status or compliance posture and remains fully consistent with the requirements under which the original version was approved.

## 4. Commitment to Compliance and Cooperation

At HUMB, we take compliance extremely seriously. Our operations adhere strictly to AML/CTF frameworks, EU regulatory obligations, and FATF guidelines. We understand Apple's commitment to ensuring that all applications on its platform meet the highest standards of legal and regulatory compliance, and we share this commitment wholeheartedly.

**Purpose:**

This appendix provides a detailed legal and regulatory overview of HUMB's Virtual Asset Service Provider (VASP) approval issued by the Bank of Lithuania. It demonstrates:

## Appendix A

### Recognition of Lithuanian VASP Approval under EU and International Frameworks

#### 1. Lithuanian VASP Approval Process

- HUMB UAB is licensed as a **Virtual Asset Service Provider (VASP)** under Lithuanian law.
- The competent authority is the **Bank of Lithuania**, the country's central bank and financial supervisory body.
- Licensing includes mandatory compliance with:
  - **Anti-Money Laundering (AML)** and **Counter-Terrorism Financing (CTF)** obligations,
  - **Know Your Customer (KYC)** procedures, and
  - Continuous monitoring by the supervisory authority.

##### **Professional Reference:**

According to **Deloitte Legal (2023)** and **Ernst & Young (EY, 2022)** regulatory briefs, Lithuania is recognized as one of the most robust jurisdictions for digital asset regulation in the EU, particularly because its VASP requirements fully implement both EU directives and **Financial Action Task Force (FATF)** standards.

#### 2. EU Recognition of VASP Approvals

- Under the **Markets in Crypto-Assets Regulation (MiCA)** (Regulation (EU) 2023/1114), licensing of crypto-asset service providers in one EU member state is valid across the **entire European Economic Area (EEA)**.
- Article 59 of MiCA establishes the **passporting right**, which ensures that a Lithuanian VASP license extends automatically to other EU member states.
- Both the **European Securities and Markets Authority (ESMA)** and the **European Banking Authority (EBA)** have published supervisory guidelines confirming this harmonized framework.

##### **Professional Reference:**

The **European Commission's Q&A on MiCA (2023)** and **Allen & Overy Legal Briefing (2023)** confirm that EU member state licenses—such as Lithuania's—carry automatic recognition across the EEA.

#### 3. International Alignment with FATF Standards

- The **Financial Action Task Force (FATF)** Recommendation 15 requires all member states to regulate VASPs with robust AML/CTF obligations.
- Lithuania's VASP framework is cited by **PwC Legal (2022)** and **KPMG Global Regulatory Insights (2023)** as being fully FATF-compliant and a model for other jurisdictions.

- Many non-EU jurisdictions accept FATF-compliant licensing frameworks as sufficient proof of international standards adherence.

**Professional Reference:**

*The **FATF Guidance on Virtual Assets and VASPs (updated 2021)** explicitly recognizes that licensed VASPs in one jurisdiction are expected to be recognized as compliant internationally, provided they meet Recommendation 15.*

#### 4. Consistency with Prior Apple Approval

- The HUMB iOS Mobile Application has already been approved and listed on the Apple App Store based on this Lithuanian VASP license.
- No changes have occurred in HUMB's licensing or compliance posture since that approval.
- Maintaining consistency with Apple's prior decision avoids uncertainty for both regulated financial service providers and Apple users.

**Professional Reference:**

*Industry experts (e.g., **Chain-analysis Compliance Report, 2023**) emphasize that regulatory continuity is critical in maintaining user trust when dealing with licensed VASPs.*

#### 5. Conclusion

HUMB's Lithuanian VASP license:

- Is fully valid and enforceable under **Lithuanian law**,
- Is **recognized across the EU/EEA** under MiCA,
- Is **aligned with FATF global standards**, and
- Has already been **accepted by Apple** for prior app approvals.

For these reasons, HUMB respectfully submits that Apple should continue to recognize its Lithuanian VASP license as a sufficient legal basis for publication of its iOS application.


